Base Metals shows lackluster performance comes despite more positive news over an initial trade agreement between the US and China.

Trump that shows support for pro-democracy demonstrators in Hong Kong - a move expected to complicate ongoing trade negotiations with China.

Chinese industrial profits fell by 9.9% year on year in October, according to data released by the country's National Bureau of Statistics. The decline marks the steepest drop in eight months.

China imports of unwrought, non-alloyed nickel were 11.99% lower on the month and 23.49% lower on the year, standing at 12,230 mt in October.

China imported 96,756 mt of copper scrap in October, down 41.15% from a month ago and 53.29% from a year ago.

China imported 1.91 million mt of copper concentrate last month, up 21.15% month on month and 21.97% year on year.
