Base Metals prices down on dwindling confidence of a long-term trade deal being struck between the United States and China weighing on the complex.

U.S. President Donald Trump stunned markets with tariffs against Brazil and Argentina, recharging fears about global trade tensions.

A senior adviser to U.S. President Donald Trump said on Monday an agreement was still possible before the end of the year, adding that the first phase of the deal was being put to paper.

Norsk Hydro , one of the world's biggest aluminium producers, plans to cut production by 20% at its majority-owned Slovalco plant in Slovakia, citing a weakening market.

Aluminium LME stocks material not earmarked for delivery, reached 1,114,650 tonnes, the highest since Feb. 22, data showed.

US Institute for Supply Management's measure of manufacturing for America unexpectedly declined to 48.1, a fourth-straight contraction.
