Oil extended gains surge in more than two months as signs of a potential U.S.-China deal and tightening American crude stockpiles bolstered prices ahead of the OPEC+ meeting.

Oman's Oil Minister Mohammed Al Rumhi said Gulf Arab members of the OPEC+ have reached a consensus on the need to prolong output cuts.

Iraq's Oil Minister Thamir Ghadhban reiterated that an additional cut of about 400,000 barrels a day may be needed to offset slowing demand.

The global benchmark crude traded at a $4.71\ {\rm premium}$ to WTI for the same month.

Kuwait's Oil Minister Khaled Al-Fadhel said he hadn't heard a suggestion for an additional cut of 400,000 barrels a day.
