Oil prices added to recent gains on Monday, with Brent nearly at \$70 a barrel as escalating tensions in the Middle East fanned worries about disruptions to supplies.

The Iraqi government on Sunday called on American and other foreign troops to leave Iraq, heightening concerns of a widening Middle East conflict that may disrupt oil supplies from the region.

The United States detected a heightened state of alert by Iran's missile forces, as President Donald Trump warned the U.S. would strike back, "perhaps in a disproportionate manner," if Iran attacked any American person or target.

Baker Hughes reported that the number of active U.S. rigs drilling for oil fell by seven to 670 this week. That followed a decline of eight oil rigs in the previous week.
