### **Base Metal Related News**

Base metals mixed with easing tensions between Iran and the United States providing a slight boost to risk sentiment.

Trump said Iran "appears to be standing down" after the latter fired missiles at two bases in Iraq that house US troops, while also advocated further sanctions against Iran rather than a military response.

Chinese data showed the CPI rose by 4.5% in the final month of last year, flat from November but below analysts' predictions of a 4.7% increase.

LME zinc stocks remain low at some 50,175 tonnes total, prompting the uptick in price action.

China's copper cathode production is estimated to slip to 734,900 mt in January from 805,500 tonnes in Dec, as cash flow issues and environmental restrictions lead to production reduction at some smelters.

China's primary aluminium output climbed to 3.04 million mt in December, to produce a year-over-year increase of 1.47%.
