### **Energy Related News**

Oil prices were steady on Friday as investors braced for data expected to show China's economic growth last year slid to its slowest pace in 29 years, holding on to gains for now after Washington and Beijing inked a long-awaited trade deal.

The IEA warned in its monthly report that supplies from Iraq, the Middle East's second-biggest producer, are potentially vulnerable due to rising political risks in the country and broader region.

China's crude oil throughput rose to a record high in 2019 following the start-up of two mega-refineries, official data showed on Friday, with December posting the highest daily run-rate on record.

China pledged \$52.4 billion in additional purchases of American energy over 2020 and 2021 in the agreement.
