## **Base Metal Related News**

Base metals prices on Monday dropped on fears that the fast-spreading coronavirus could have a negative impact on the domestic economy.

Investors have been drawing parallels between the current virus and the SARS crisis that claimed almost 800 lives 17 years ago and crimped China's economic growth.

The WHO director-general said on Tuesday that he is confident in China's ability to control and contain the spread of a new coronavirus, China's Ministry of Foreign Affairs said.

In Shanghai, authorities advised that companies shouldn't start work until at least Feb. 9.

This virus will push China's manufacturing PMI back into contraction, and put a bigger dent in the non-manufacturing PMI than expected.

The flash January PMIs for the euro area and Japan showed improvement, while that of the U.S. stayed in expansionary territory.
