Crude prices fell more than 2% to multi-month lows on Monday as the rising number of cases of the new coronavirus in China and city lockdowns there deepened concerns over oil demand.

China's new coronavirus to curb travel and economic activity in China and elsewhere has already pushed oil prices down by 10% since early last week.

Libya's oil output could be days from coming to a complete halt as conflict in the OPEC nation puts the country's most vital industry at risk.

Front-month oil contracts have been hit by a sell-off as the coronavirus prompts a lock-down in parts of China; advisories discouraging travels to and from the country are also expected to weigh on oil demand and consumption.

US natural gas futures were on track to drop to their lowest since March 2016 on forecasts for mild weather through early February and a small decline in liquefied natural gas exports. despite production slow down.
