Oil extended its recovery from a virus- induced slump as a report showing a drop in U.S. crude inventories, a rebound on Wall Street and speculation OPEC+ will step in to prop up prices reassured investors.

The American Petroleum Institute reported stockpiles fell by 4.27 million barrels last week.

The Organization of Petroleum Exporting Countries and its allies could deepen output cuts at its next meeting in March to take account of lower demand due to the virus.

British Airways suspended all direct flights to and from mainland China after Britain warned against all but essential travel to the country, and jet fuel demand has slumped in Asia as airlines have canceled connections.

Natural Gas inventories probably -201 bcf last week as compared to last week's -92bcf.
