Energy Related News

Oil prices rose amid investor optimism over unconfirmed reports of possible advances in combating the coronavirus outbreak in China which could cause fuel demand to rebound in the world's biggest oil importer.

A committee that advises the OPEC and allied producers, a group known as OPEC+ is set to meet for a third day on Thursday.

The Joint Technical Committee for OPEC+ has been meeting this week to consider increasing output cuts by an additional 500,000 bpd or to extend current cuts beyond March. OPEC+ ministers are due to meet on March 5 and 6.

Commodity supply chains in China have been disrupted to the extent that short-term sales of crude oil, along with LNG, fell to nearly zero this week.

Brent and WTI remain in contango LCOc1-LCOc2, a situation where longer-dated futures trade at a premium to shorter dated ones, a sign that the market sees ample supply or falling demand for crude.
