Energy Related News

Oil prices rose after prices found a floor amid uncertainty over how the coronavirus will play out and whether OPEC+ will respond with additional production cuts.

The WHO said the spike doesn't necessarily reflect a sudden surge in new infections, with many of the added cases dating back days and weeks.

The other big uncertainty is whether Russia will back an OPEC+ proposal to temporarily deepen output reductions by 600,000 barrels a day in the second quarter.

Global crude oil demand in the first quarter of this year is forecast to hit the slowest rate of growth in 10 years amid the coronavirus outbreak, according to the International Energy Agency.

U.S. EIA reported that domestic supplies of natural gas fell by 115 billion cubic feet for the week ended Feb. 7.
