Base Metal Related News

Base metals prices mixed with recent Chinese stimulus measures providing slight support to the complex while worries about the economic impact of the novel coronavirus continue to loom.

China's National Health Commission reported 1,749 new confirmed cases of coronavirus infections, the lowest daily rise since Jan. 29. The death toll, however, passed 2,000.

Firms in Hubei province will not have to pay pensions, jobless and work-injury insurance until June, while a Bloomberg report, citing sources, said China is considering cash injections or mergers to bail out airlines.

The dollar index is rising and trading at 99.4, compare to a reading of 98.75 at roughly the same time a week ago.

China's imports of refined copper are likely to slide for a second year running in 2020, while the country's aluminium consumption will dip slightly after a rare fall in 2019, research house Antaike said.
