# **Energy Related News**

Crude prices fell more than 3% towards a one-week low on Monday as the rapid spread of the coronavirus in several countries outside China left investors fretting about a hit to demand.

OPEC hasn't decided yet to extend or modify its agreement to cut oil output, Saudi Arabia's energy minister said.

Global oil demand will drop this quarter for the first time in over a decade as the outbreak of the coronavirus batters China's economy, creating a significant supply surplus, according to the International Energy Agency.

Russia hasn't said whether it will support a proposal by the coalition known as OPEC+ for deeper production cuts of 600,000 barrels a day.

The Lower 48 U.S. states' working natural gas in storage will end the 2019–20 winter heating season (Nov. 1–March 31) at 1.94 trillion cubic feet (Tcf), 12% more inventory than the previous five-year average, the EIA forecast
