Base metals prices down as risk appetite remains suppressed by news that the novel coronavirus (2019-nCOV) continues to spread around the world, with nearly 100,000 people infected globally.

The World Health Organization warned of a global shortage and price gouging for protective equipment to fight the fast-spreading coronavirus as the virus spread to some 80 nations and infected around 91,000 people.

Alumina suppliers increased their offer prices amid tightened availability of raw material.

Aluminium inventories tracke by SHFE climbed to their highest in 8 and half months at 439,087 tonnes by the end of last week.

US President Trump said the economy might take a hit from the outbreak but predicted the challenge would eventually pass.

Investors are triggering expectations of earlier interest rate cuts in China.
