## **Base Metal Related News**

Base metals prices fell on Thursday as the World Health Organization (WHO) declaring the coronavirus outbreak a pandemic raised fears that it would further dampen economic growth.

The WHO on Wednesday described the outbreak that has killed more than 4,300 people and infected over 121,500 a pandemic.

U.S. President Donald Trump suspended all travel from Europe, not including the United Kingdom, to the United States for 30 days starting on Friday to fight the virus.

China confirmed only eight new coronavirus infections in Hubei province, the first time the epicentre of the pandemic recorded a daily tally in single-digits.

U.S. aluminium premiums could jump by 80% to about 25 cents a lb if President Donald Trump boosts U.S. tariffs in a bid to help domestic smelters ahead of the election
