# **Base Metal Related News**

Base metals prices fell on demand worries, as an emergency rate cut by the U.S. Federal Reserve failed to ease concerns about the rising economic toll of the coronavirus pandemic.

China's aluminium production rose by 2.4% year-on-year in the first two months of 2020.

Shanghai Futures Exchange copper inventories rose another 10% in the past week to their highest in almost four years.

In its second emergency rate cut, the Fed slashed interest rate to near zero on Sunday. However, hat failed to give confidence to the investors, leading a fall in copper prices.

Nickel ore mines and exporters in the northern part of Surigao, which is the major nickel ore producing region in the Philippines and produces nickel ore of good quality, will have to suspend shipments for two weeks on the back of the ban.
