Oil prices fell sharply as the global coronavirus pandemic worsened and the Saudi Arabia-Russia price war showed no signs of abating.

U.S. President Donald Trump and Russian President Vladimir Putin agreed to discuss stabilizing energy markets, but prices remain near 18-year lows as the coronavirus shutdown destroys demand.

Saudi Arabia planned to boost its oil exports to 10.6 million barrels per day (bpd) from May on lower domestic consumption, a Saudi energy ministry official said

Global oil refiners have cut their production due to the slump in demand for transportation fuel, European refineries slashing output by at least 1.3mbpd.

The US is likely to lose its spot as world's top oil producer this year as budgets have been slashed and capital investments have been put on hold in America's shale country in the wake of the massive price slide
