## **Precious Metals News**

Gold prices eases as the U.S. dollar and global equities strengthened on signs of a slowdown in coronavirus-related deaths.

Asian markets looked poised to attempt another day of gains after stocks rallied on signs of easing coronavirus deaths, as oil prices resumed their decline on doubts about a potential Saudi-Russian pact to cut output.

The Federal Reserve moved to bolster a new small-business lending program by allowing banks to turn those loans over to the U.S. central bank for cash, easing concerns among banks about getting the low interest loans.

Japanese Prime Minister Shinzo Abe pledged on Monday to roll out an unprecedented economic stimulus package, equal to 20% of economic output.

India's gold imports plunged more than 73% year-on-year in March to their lowest in 6-1/2 years.

SPDR Gold Trust said its holdings rose 0.54% to 984.26 tonnes on Monday.

### **Precious Metal Outlook**

Precious metals are trading higher in the morning trade. We expect prices to trade positive as the coronavirus outbreak that has crippled the global economy appears to be de-escalating a bit and increasing economic stimulus from the major economies are providing support to the prices.
