Base metal prices are volatile that is being continually battered by worries over the Covid-19 pandemic and its effects on global economic growth.

Copper rose supported by a slowdown in the death toll from coronavirus in some European countries and falling inventories, though fears of recession continued to weigh on prices.

The number of deaths and new infections from the coronavirus eased in countries including France, Italy and Spain

Meanwhile Japan became the latest country to unveil a stimulus package to cushion its economy against a knock from the epidemic.

Stocks of copper have been in steady decline since hitting a 2020 high of 220,325 tonnes on March 17..

Copper producer Antofagasta said it would suspend operations at its Los Pelambres Expansion project in Chile for four months due to coronavirus.

Three employees at a New Mexico mine owned by Freeport-McMoRan Inc have tested positive for COVID-19
