Base metal prices fell as investors weighed rising tensions between the US and China against mounting optimism about a potential vaccine.

The London Metal Exchange aluminium cash/three-month spread recently traded at a \$25.50 per tonne contango on Friday, narrower from as wide as wide as \$37 at the beginning of the week.

White House National Security Advisor Robert O'Brien said the US will likely impose sanctions on China if Beijing implements national security law that would give it greater control over autonomous Hong Kong.

The London Metal Exchange is closed on Monday for the Spring Bank Holiday and reopens on May 26.

China's Tongling Nonferrous will in July start up a new 400,000 tonnes per year copper smelting project in Inner Mongolia after shutting down an older plant
