Oil prices fell on Thursday after U.S. industry data showed a surprise steep build in crude oil inventories, dampening hopes of a smooth recovery in demand as some countries ease coronavirus lockdowns.

API reported that US crude stockpiles rose 8.73 million barrels for the week ending May 22. U.S. gasoline stockpiles rose by 1.12 million barrels last week, while supplies at the storage hub of Cushing, Oklahoma, fell by 3.37 million

Russian President Vladimir Putin and Saudi Arabia's Mohammed bin Salman reiterated their cooperation on the agreement ahead of a June 9-10 meeting.

OPEC+ will be closely watching to see whether U.S. shale oil producers, who have breakeven prices in the high \$20 and low \$30 dollar range, step up production

Meanwhile, Chinese lawmakers approved a Hong Kong security legislation, setting the stage for increased tensions with America.
