Base Metal Related News

Base metal prices traded on a mixed note following a broad rally overnight, as market participants digested the Federal Reserve's latest policy decision and outlook for the economy over the coming years.

Chilean copper miners' unions called on Sunday for a re-evaluation of the operational continuity plans of the country's biggest miners during what they said was an "alarming" increase in coronavirus cases among workers.

Copper trading on the CME and LME tumbled last month as funds and speculators fled from high volatility during the coronavirus pandemic, but volumes in China as lockdowns were lifted.

Copper prices have since rebounded by about a third to around \$5,800 sine March low, but volumes and open interest have remained subdued.

Beijing has recorded dozens of new cases in recent, while new virus cases and hospitalizations in record numbers swept through more U.S. states.

Shanghai Lead inventories more than doubled over the past week on higher output and subdued Chinese demand
