## **Base Metal Related News**

Copper prices rose to their highest in more than five months supported by mounting supply risks in top producer Chile and upbeat manufacturing data in major economies.

About 165,000 heavy trucks are estimated to have been sold in China last month, marking the highest for the month of June on record,

China's copper concentrate imports fell sharply in May as COVID-19 lockdown restrictions ex-China introduced in late March began to take their toll.

On the coronavirus front, there were positive news overnight around the development of a potential vaccine. A study of a coronavirus vaccine candidate being developed by Pfizer and BioNTech showed the drug created neutralizing antibodies.

The US dollar slipped on Wednesday in choppy trading, with the market having a modest appetite for risk-taking amid generally upbeat US data and improving European economic numbers.
