Gold prices steadied, as worries over surging coronavirus cases and U.S.-China tensions underpinned its safe-haven appeal, although a stronger dollar capped gains.

Gold is being held up due to rising geopolitical uncertainty, and a resurgence of coronavirus cases in the United States as well as across the world.

The United States reported at least 70,000 new COVID-19 cases on Thursday, a record daily increase for the seventh time this month

New York Fed President John Williams said it could take a few years for the U.S. economy to recover from the damage caused by the pandemic, and it was not yet the time to think about raising interest rates

Markets also kept a wary eye on China's trade relations with the U.S., with Washington considering a ban on travel to the United States by all members of the Chinese Communist Party and their families

ECB will use its stimulus firepower fully, even as the euro zone economy shows some signs of rebounding, ECB President Christine Lagarde said.

Precious Metal Outlook

Precious metals are trading lower in the morning trade. We expect prices to trade rangebound amid uncertainty about the economic recovery and strong U.S. retail sales. However uncontrolled monetary policy and stimulus measures will continue to push gold prices higher.
