#### **Base Metal Related News**

London copper dipped as heightened Sino-U.S. tensions sparked worries of a tit-for-tat retaliation dampenening economic growth and demand.

Asian markets appear set to open with a firmer tone, shrugging off an overnight fall in U.S. stocks as the United States prepares to debate fresh economic stimulus to see the country through its coronavirus outbreak

The Trump administration is considering to ban travel to the United States by all members of the Chinese Communist Party and their families, a person familiar with the matter said on Thursday.

China's primary aluminium production rose to 3.02 million tonnes - its highest in six months - in June.

The ECB will use its stimulus firepower fully, even as the euro zone economy shows some signs of rebounding, ECB President Lagarde said.

The United States said it had not ruled out further sanctions on top Chinese officials to punish China for its handling of Hong Kong.

The US dollar rose while global stocks fell, as investors reacted to a mixed batch of economic data out of China and the US.
