Oil prices mixed on Monday with U.S. crude rising as a tropical storm in the Gulf of Mexico forced rigs to shut down, but the gains were kept in check by wider concerns about excess supply and falling demand for fuels.

Tropical Storm Sally gained in strength in the Gulf of Mexico west of Florida on Sunday and was poised to become a category 2 hurricane.

In Libya, commander Khalifa Haftar committed to ending a months-long blockade of oil facilities, a move that would add more supplies to the market

The lower demand and higher storage inventories will offset any production loss of naturalgas.

On Thursday, Saudi Arabia and Russia will chair a monitoring meeting to assess whether the vast production cuts, which they started easing in August

The holiday season in US has passed and yet the rush hour traffic is limited and crdueoil inventories are high.
