U.S. natural gas futures for the most active month fell over 6% on forecasts for less demand over the next two weeks and a rise in output.

Oil prices extending large losses from the previous as rising coronavirus cases heading into the northern winter prompted concerns about further restrictions on activity that could curb fuel demand.

Libya's Sarir oilfield, which was producing more than 300,000 bpd last year, restarted output after eastern forces lifted an eight-month blockade.

A threat to supply emerged in Norway with oil workers organised by the Lederne labour union planning to strike following a breakdown in wage talks

Meanwhile, the American Petroleum Institute reported a weekly drop in U.S. crude stockpiles, while Cushing supplies and gasoline inventories rose

Royal Dutch Shell has said it plans to cut 7,000 to 9,000 jobs as it responds to challenges including the slump in oil demand amid the Covid-19 pandemic.
