Energy Related News

Oil prices fell after President Trump said he's halting stimulus talks until after the election, sapping optimism for a much-needed boost in demand.

U.S. Gulf operators shut 29% of oil output in the region ahead of Hurricane Delta. The storm strengthened to a Category 4 and is expected to move through the U.S. Gulf before hitting Louisiana

The API report also showed crude rose 0.95 mbpd gasoline stockpiles falling 867,000 bbls last week, while distillate supplies fell more than 1 mbbls.

In Norway, meanwhile, the Lederne labour union said on Tuesday it will expand its ongoing oil strike from Oct. 10 unless a wage deal can be reached in the meantime.

NG prices fell over 3% on forecasts for milder weather and lower demand over the next two weeks than previously expected and worries Hurricane Delta could disrupt liquefied natural gas (LNG) exports.

Crude oil prices are trading lower for the day. We expect oil prices may trade sideways to down on unexpected rise in crudeoil inventories and after Trump stopped the talks on next stimulus bill until elections. Currently the supply side factors are supporting prices as the workers strike in Norway has cut down 8% of the oil output in the region however the outlook for global oil demand remains patchy with stricter lockdowns coming into force in parts of Europe and the U.S.
