# **Energy Related News**

Oil erased some gains howEver supported on the back of supply cuts caused by a storm in the Gulf of Mexico and a strike of offshore workers in Norway.

Brent's six-month contango, implying current oversupply, has shrunk to around \$1.90 a barrel from \$3.24 less than a month ago.

Norwegian oil company and labour officials said they would meet with a state-appointed mediator on Friday in an attempt to bring an end to a strike.

Producers have also halted nearly 62% of the region's natural gas output, or 1.675 billion cubic feet per day due to Hurricane Delta.

 $\ensuremath{\mathsf{OPEC}}$  said world oil demand will plateau in the late 2030s and could by then have begun to decline.

EIA said utilities injected 75 billion cubic feet (bcf) of gas into storage in the week ended Oct. 2.

Crude oil prices are trading lower for the day. We expect oil prices may trade sideways to positive as the supply side factors are supporting prices after the workers strike in Norway has cut down 8% of the oil output in the region. The current rally in oil prices depends on the Hurricane Delta moving into Category 3 and Norway strike may further tighten oil output if no deal occurs on 14th Oct between workers.
