Oil rose after recent sharp losses, but market sentiment remains muted as surging COVID-19 cases around the world hurt the outlook for crude demand while supply is rising.

The record numbers of new cases in US, Russia, France forcing them to impose fresh restrictions as winter looms.

Saudi Arabia's Energy Minister Prince Abdulaziz bin Salman said the worst is over for the crude market.

Libyan production is expected to reach 1 mbpd in the coming weeks.

OPEC+ is planning to increase production by 2 million bpd from the start of 2021 after record output cuts earlier this year.

U.S. natural gas prices are highest in nearly 2 years on forecasts for higher heating demand and concerns that a storm could disrupt Gulf production.
