Oil prices gained for a third day as a Democratic sweep in the U.S. stoked optimism around the prospect of more fiscal stimulus under the incoming Joe Biden administration.

Democrats are poised to take control of the Senate, House and presidency, setting the stage for additional virus aid that could boost ailing fuel demand.

Saudi Arabia's decision to unilaterally cut production by 1 million barrels a day in February and March set off a sharp rally along the oil futures curve

Crudeoil closer dated contracts above \$2 a barrel and near its strongest level since October 2018 on a settlement basis.

EIA reported that domestic supplies of natural gas declined by 130 billion cubic feet for the week ended Jan. 1.
